# BRITISH BROADCASTING CORPORATION CONTRACT

Thank you for your request of 29 October 2022, for a copy of a contract awarded by the British Broadcasting Corporation (BBC) to Incorporated London Limited. This contract was awarded and commenced on 11 September 2015 and published on 6 October 2015.

Your request was considered in accordance with the terms of the Freedom of Information Act 2000 (FOIA), and it has been reproduced at Annex A for your reference.

Having searched our audit records and archives, we can confirm that we do not hold information within the scope of your request. It is possible that we never held a copy of the contract, as it dates back to 2015 which is prior to the National Audit Office taking on the financial audit of the BBC. Alternatively, if we did previously hold a copy, it would have been destroyed in accordance with our records retention and disposal schedules, which for this type of material is six years. You may wish to contact the BBC to ask if they still hold a copy of the contract.

We are sorry that we are unable to help on this occasion. Annex B sets out the steps you may wish to take if you are not satisfied with the way we have handled your request for information under the FOIA.
