SOVEREIGN HOUSING ASSOCIATION

Thank you for your request of 10 July 2023 for information about the amount of money spent on a legal case by Sovereign Housing Association (Sovereign). We have considered your request in accordance with the terms of the Freedom of Information Act 2000 (FOIA). Your specific request is reproduced at Annex A.

It may help if I first explain the role of the NAO, which is independent of government, has three main functions. The first is to certify the accounts of central government departments and a wide range of other public sector bodies, and to express an opinion on those accounts. The second is to carry out examinations into the economy, efficiency and effectiveness with which government departments and other public sector bodies have used their resources. The third is to maintain a Code of Audit Practice and issue guidance to external auditors of local public bodies including local authorities.

The NAO has no remit to investigate individual housing associations such as Sovereign. For this reason, we have not carried out an audit of Sovereign and do not hold the information you requested about the money it has spent.

You would need to contact Sovereign directly about this matter. If you have already done so and are unhappy with the response you received, you can make a complaint. If you remain dissatisfied after exhausting this process, you can refer the matter to the Housing Ombudsman, who may be able to investigate.

Annex A

Request for information about Sovereign Housing Association:

"I am writing to enquire about an information request into the amount tax payers money abused and wasted by Sovereign Housing Association since 2021. They have spent a minimum of £50,000 on a baseless legal case which they then dropped in May 2023 with no outcome. Their case was riddled with hundreds of false allegations for which they had no evidence what so ever. Their Barrister charges £3,500 for 30 minute hearings in court which is charged to the tax payer.

They are now currently acting as a proxy for one of their tenants using tax payers money, interfering in court proceedings and writing pages of inappropriate and fabricated statements regarding their case that they dropped when they had the chance to take it to trail and have an outcome. Their solicitors are making thousands of pounds from the tax payer and enjoy delaying the legal process, playing games to complicate and stretch out what should be an very quick resolution. They used tax payers money to bring a baseless case to court which they dropped in an attempt to silence and prevent justice. They did this because they have the tax payers money on tap at their disposal.

The CEO of Sovereign Housing Association is aware of the waste of tax payers money but sits quiet. Their ASB officer who is leading this outrageous behavior and cost to the tax payer is paid by the tax payer also.

As a 40% tax payer I would like to know how much of the tax payers money Sovereign Housing Association has wasted on the legal case which their dropped and had no outcome, i would like to know how much money they have further wasted since May 2023 on unnecessary legal costs and salaries of the resources for their unnecessary involvement in the legal case and hearing on 5 June 2023.

I firmly believe that this is also now in the interest of the public."
