COVID-19 VACCINATION STORAGE AND DISTRIBUTION COSTS

Thank you for your request of 18 July 2023 for information about COVID-19 vaccination storage and distribution costs. We have handled your request under the terms of the Freedom of Information Act 2000 (FOIA). Your request is set out in **Annex A** for reference.

We have reviewed our records and can confirm that we do not hold the information that you have requested.

While we do not hold the specific information you have requested, you may be interested in Figure 2 on page 18 of our report The rollout of the COVID-19 vaccination programme in England which shows a slightly more detailed breakdown of expenditure up to the end of October 2021. As per the table notes of Figure 2 and paragraph 7 of Appendix 2, it is worth noting that this analysis reflected our best understanding at the time of the report, but there were limitations and uncertainty in the completeness and quality of the financial and contractual information available to us.

Information about the costs associated with ultra-cold chain and cold chain storage and distribution of the vaccine may be held by DHSC and/or NHS England. Within the N.A.O report "The rollout of the COVID-19 vaccination programme in England" on page 4 it states that £2.2 billion was spent on COVID-19 vaccine distribution and deployment in England to the end of October 2021.

Could you provide a breakdown for the ultra-cold chain (-20C or below) and cold chain (2-8C / refrigerated / 4C) storage and distribution costs?

Specifically, I would like to know the following breakdown:

- Ultra-cold chain storage costs
- Ultra-cold chain distribution costs
- Cold-chain storage costs
- Cold-chain distribution costs
- Total storage costs
- Total distribution costs

I would like you to provide this information in Excel format."
