International hospitality provided by the National Audit Office (NAO): 1 October 2024 to 31 March 2025

International hospitality: 1 October 2024 to 31 March 2025

As a leading Supreme Audit Institution (SAI), the NAO engages with its counterparts in other countries. Our international engagements improve our support to the UK Parliament by:

- Bringing global perspectives and access to comparative data to our UK work, providing insights into how different countries tackle relevant issues, such as climate change mitigation and adaptation, public sector efficiency and disaster preparedness and response.
- Sharing knowledge and importing good practices from other audit offices, benchmarking our own audit approaches and use of data analytics.
- Strengthening accountability and transparency in international institutions and countries which are recipients of UK taxpayer funding.

In support of these objectives, between 1 October 2024 and 31 March 2025, the NAO hosted:

- Nine bilateral meetings with other SAIs;
- A two-day meeting of the EUROSAI¹ Governing Board (of which the C&AG is a member). The Governing Board meeting was attended by eight Board members, their heads of international work and observers from EUROSAI and INTOSAI member countries. In total there were 45 people from 18 countries.
- A two-day meeting of the Financial Audit & Accounting Subcommittee of INTOSAI² of which the NAO is the chair. In total 31 people from 17 countries attended including NAO technical staff and representatives from ICAEW.
